Family history research in Canada can be very fun and rewarding. Learn about Canada's history, background, and records for each province and territory to help you begin your family history research. Many of the records for Canada are digital and are readily available at major genealogical websites such as FamilySearch, Ancestry.com, and Library and Archives Canada.

History and Background

European colonization in Canada began when Norsemen built temporary fishing camps along the eastern coast about 1000 AD.

Significant dates in Canadian history

1763: End of Seven Year's War (French and Indian War), most of Canada came under British rule

1783–1784: After American Revolution, 30,000+ Loyalist refugees fled to Canada

1783–1784: Loyalists settled the following areas:

- Coastal regions
- Eastern Townships of Quebec
- Area between Ottawa and St. Lawrence river valleys (known as Upper Canada or Ontario)

1784: New Brunswick separated from Nova Scotia

1800–1815: Around 35,000 people immigrate to Upper Canada. These include 23,000 Loyalists, "late Loyalists," and their descendants. They were mainly from upstate New York, New Jersey, and Pennsylvania.

1815–1850: The great immigration was from Scotland and Ireland to the Atlantic colonies. Every year a few thousand immigrants came. During the Famine Migration from Ireland, tens of thousands settled the farms and towns of Upper and Lower Canada. Many went to New Brunswick

1841–1867: Ontario was called Canada West and Quebec was Canada East

1867: Canada confederation brought about self-rule and united Ontario, New Brunswick, Nova Scotia and Quebec.

1881: Settlement in Manitoba increased as immigrants and farmers from Ontario headed west.

Provinces and Territories

Canada consists of 10 provinces and 3 territories

Maritime or Atlantic Provinces

- New Brunswick, July 1, 1867

- Nova Scotia, July 1, 1867
- Prince Edward Island, July 1, 1873
- Newfoundland, March 31, 1949

Central Provinces

- Ontario, July 1, 1867
- Quebec, July 1, 1867

Prairie Provinces

- Alberta, Sept. 1, 1905
- Manitoba, July 15, 1870
- Saskatchewan, Sept. 1, 1905

Nunavut

- Separated from Northwest Territories, April 1, 1999

Northwest Territories, July 15, 1870, (north of the Prairie Provinces)

Includes the following areas:

- Arctic island
- Islands of Hudson Bay

West Coast Province

- British Columbia, July 20, 1871
- Yukon Territory, June 13, 1898
- Land north of British Columbia

Vital Records

- Each province is responsible for vital records
- Registration for all provinces was not complete until the 1920s
- Dates for vital records vary by province

Census Records

- The national government of Canada has taken a census every ten years since 1871
- The last national Canadian census available to the general public is the 1921 census
- For the years 1842-1871 some partial or incomplete censuses exist for some areas but do not cover all modern-day Canada

Introduction

- National census records are arranged by province and within provinces by census districts and subdistricts.
- Census districts are voting districts, not counties. Although a voting district may have the same name as a county, it may not include the same townships.

Naturalization and Immigration

Naturalization

- Before Canada became a nation (pre-1867) naturalization was completed in accordance with the laws of the provinces or with British law
- Between 1763 and 1947, non-alien residents of Canada were considered British subjects
- Settlers from England, Scotland, Ireland, and Wales had no need to naturalize in Canada.

You may find evidence that an ancestor completed citizenship requirements in one of the following documents

- Censuses
- Court minutes
- Homestead records
- Passports
- Voting registers
- Military papers

History and Background

1828: Naturalization Act where Upper Canada (Ontario) gave men British citizenship after 7 years of residency

1841: Naturalization Act after the union of Lower and Upper Canada

1868: A local Act known as Law of Naturalization and Allegiance which required naturalization to be a federal process (although provinces retained some jurisdiction)

Naturalization

History and Background

1914: Naturalization Act required the federal Department of Citizenship and Immigration to issue naturalization (began in 1916)

1947: Canadian citizenship was established and became separate from British citizenship

Naturalization Databases

Library and Archives Canada has databases for some limited collections including:

- Naturalization Records, 1828-1850 for Upper Canada/Canada West (present day Ontario)
- Citizenship Registration Records, 1851-1945 for the Montreal Circuit Court
- Naturalization Records, 1915-1951

Canada Gazette

- From 1915-1951, the Canada Gazette published all naturalizations as part of the annual report of the Secretary of State. There are two parts to the database:
- 1915 to 1946—published in certificate number order. The name index allows you to search by first or last name and country.
- 1947 to 1951—contains digital images of naturalizations published in the *Canada Gazette*. It is searchable by month and year of publication.

Published naturalization records include:

- Name
- Country of origin (or for a wife or child, the relationship to the person being naturalized)
- Date naturalization certificate was issued
- Occupation
- Residence
- Certificate number and series

Immigration Records

Immigration records are sources that give information about the movement of groups or individuals from one place to another, usually between nations

- Immigration—to enter
- Emigration—to leave

Pre-1865

- Library Archives Canada has immigration documents showing emigrants to Canada between 1750 and 1854 (about 28,000 entries)
- Some of these are available digitally, other documents will need to be requested

Post 1865

- Passenger lists for various ports 1865-1922
- Passenger lists for the Port of Quebec City and other ports 1865-1922
- Immigrants from China, 1885-1949
- Ukranian Immigrants 1891-1930
- Immigrants from the Russian Empire 1898-1922

Other Records

Church Records

- Church records were first recorded in Canada starting in the 1620s with the French settlements in Quebec
- Because many provinces did not keep vital records until after confederation in 1867, church records are crucial to research in earlier time periods

Church Records

- Three-fourths of Canadians claim a connection to one of four churches:
 - Roman Catholic Church
 - Anglican Church of Canada
 - United Church of Canada
 - Presbyterian Church in Canada
- If you are not sure of the religious affiliation of your ancestor, check the census records, as census records asked about religion

The Drouin Collection

- The Drouin collection is a collection of Catholic Records submitted to the government by churches to be registered civilly
- The Drouin collection includes records from many denominations across Quebec including Catholic, Presbyterian, Church of England, Baptist, Methodist, and others
